### ARTICLES OF INCORPORATION

# Angela Courte Ministries, Inc.

# A Non Profit Corporation

The undersigned, being over the age of eighteen (18) years and competent to contract, for the purpose of organizing a Corporation not-for-profit pursuant to the laws of the **State of Florida**, does hereby adopt the following Articles of Incorporation, and does hereby agree and certify as follows:

# ARTICLE I

# NAME

The name of this Corporation shall be Angela Courte Ministries, Inc.

# **ARTICLE II**

# PRINCIPAL OFFICE

The physical and mailing address of the principal office of the Corporation shall be 11059 International Drive, Orlando, FL 32821.

### ARTICLE III

# **PURPOSE AND POWERS**

- (1) The purpose for which the Corporation is organized and operated is exclusively for charitable, religious, and educational including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(C)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Such purposes shall include the following:
- (a) To equip men, women, and children with vital truths that leads them to seek God in every aspect of their lives, thereby empowering them to make a difference in the lives of others.
- (2) As a means of accomplishing the above purposes and methods, the Corporation shall have the following powers:
- (a) To receive and accept gifts of money and property and to hold the same for any of the purposes of the Corporation and its work.
- (b) To raise and assist in raising funds for the purposes herein set forth.

- ·(c) To acquire, own, lease, mortgage and dispose of property both real and personal.
- (d) To accept property and donations in trust for religious or charitable purposes.
- (3) The property of the Corporation is irrevocable dedicated to religious, educational and charitable purposes, and no part of the net earnings of the corporation/organization shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation/organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501 (c)(3) purposes.
- (a) No substantial part of the activities of the corporation/organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation/organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.
- (b) The Corporation shall not:
  - (1) operate for the purpose of carrying on a trade or business for profit;
  - (2) accumulate income, invest income, or divert income, in a manner endangering its exempt status; or
  - (3) except to an insubstantial degree, engage in any activity or exercise any powers that are not in furtherance of the purposes of the Corporation.

### ARTICLE IV

# MANNER OF ELECTION

Directors shall be elected as set forth in the Corporation's Bylaws.

### ARTICLE V

# INITIAL REGISTERED AGENT AND OFFICE
