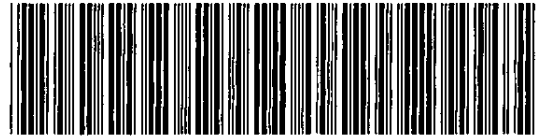

ARTICLES OF INCORPORATION

ARTICLE ONE.

The name of this corporation is **YAHWEH BCTA Gods Time Ministry Florida Church, Inc.**

ARTICLE TWO.

OBJECTS AND PURPOSES

The objects and purposes for which this corporation is formed are:

To conduct and transact generally the business of a religious organization or **Church & Sports Ministry** / corporation and to do all things and exercise all powers and perform all functions that a **None Profit** corporation is authorized or empowered to do, exercise, or perform under and by virtue of the laws of **Florida**, or that it may be by law hereafter authorized to do, exercise, or perform; **Church and Sports Ministry** and do all the above things as a **501 (c) (3)** corporation and insofar as is consistent with the laws of (the state of **Florida**.)

ARTICLE THREE.

LOCATION OF PRINCIPAL OFFICE

Every five years the president will appoint a new Board of Directors. The board will consist of Church members; coaches, parents of Attending students in good standing and professional with good standing within the church. The position of President can only be filled by a Family member, of the original President. He or she must hold the position of Apostle. The position must be filled or the corporation will no longer exist as it was intended. Remaining family members can therefore take control of assets and continue to run, as is stipulated in Article two; i.e. as a Church and Sports Ministry. The Vice president position will be held by the first Lady of the Church. The first lady or Vice president is the Wife of the Apostle. If there is a male or female here then the positions can be reversed. I.e. the female here becomes the Apostle and her husband the Vice president. This is to be stipulated upon the death of the Original Apostle and First Lady..

DURATION OF CORPORATE EXISTENCE

The corporate existence of this corporation shall continue perpetually.

In witness whereof, we, the incorporators, have set our hands and seals on this day May 20th 2008. The purpose of the organization known as Yahweh BCTA is to provide the community with services in Christian Ministry through sports. It will provide educational opportunities and grants for children to further their academic development. Under privileged children and orphans will be considered primary.


Dissolution of Assets

If there is no family or representative of original Board of Directors to handle the assets from the None Profit organization of Yahweh BCTA, the remaining assets of the organization will go to the widows and orphans of the State of Florida.

Yahweh BCTA will sponsor student, individuals through scholarship programs and educational assistance. These individuals will not be related to the family of the Apostle or his Board of Directors.




