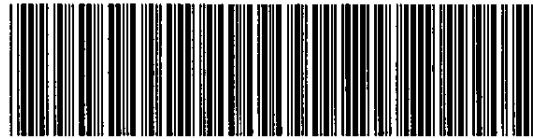

#### ARTICLE IX. DISSOLUTION

In the event of dissolution, the residual assets of the organization will be turned over to American Cancer Society (Sebring Relay for Life), Alzheimer's Association (Florida Gulf Coast Chapter), and Boys and Girls Club of Highlands County (Sebring Branch or their successor organizations which themselves are exempt as organizations described in sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State or local government for exclusive public purposes.

#### Article III

The specific purpose for which this corporation is organized is to promote and advance the professional development of local amateur musical talent while also providing an annual event that improves the social qualifications of our community.
