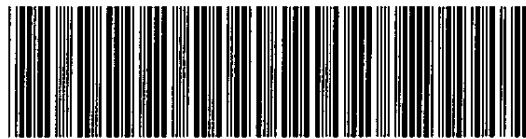

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a corporation in accordance with the laws of the State of Florida for philanthropic purposes in accordance with Florida Statutes Section 617, as a school for education and rehabilitation to children with physical disabilities.

**ARTICLE I.- NAME**

The name of this corporation is NO LIMITS ACADEMY, INC.

**ARTICLE II.-NATURE OF CORPORATION**

The general nature of the business to be rendered by this corporation is provide both educational and medical based therapy along with an exceptional education which complies with the standards of the Americans with Disabilities Act in its educational and functional goals to produce better outcomes for children with physical disabilities. In order to promote its purpose, the Corporation may acquire property by grant, devise, or bequest and hold and dispose of such property as the Corporation shall require for the benefit of the members and purposes of the Corporation and not for pecuniary profit.

**ARTICLE III.-TERM OF EXISTENCE**

This corporation shall have perpetual existence.

**ARTICLE VI.-ADDRESS**

The initial address of the principal office of this corporation is: 4450 W. Eau Gallie Blvd., Suite 180, Melbourne, Florida 32934.

#### **ARTICLE V.- DIRECTORS**

This corporation shall have two (2) directors initially. The number of Directors may be increased or diminished from time to time, by By-Laws adopted by the members and shall never be less than two (2). Election of Directors and Officers of the Corporation shall be in accordance with the provisions contained in the By-Laws.

#### **ARTICLE VI.- INITIAL DIRECTORS**

These Articles of Incorporation and the By-Laws of this Corporation may be amended in the manner provided by law.

#### **ARTICLE VII - CORPORATE EARNINGS**

All net earnings of the Corporation shall be utilized to benefit the disabled children. No part of any net earnings of the Corporation shall ever benefit any member and no member shall ever receive any dividends or profits.

#### **ARTICLE VIII - DISSOLUTION**

In the event of a dissolution of this Corporation, the

residual assets of the Corporation shall be turned over to one or more organizations which are themselves exempt as organizations described in section 501 c (3) and 170 c (2) of the Internal Revenue Code of 1986, as amended, or to conform to the Federal, State or local government for exclusive public use.

#### **ARTICLE IX - REGISTERED AGENT**

#### **ARTICLE X-CHARITABLE PURPOSE OF CORPORATION**

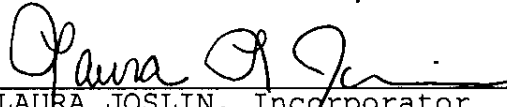
This Corporation is organized exclusively for charitable and educational purposes, including, but not limited to such purposes as the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code.

#### **ARTICLE XI-USE OF CORPORATE EARNINGS**

Notwithstanding any other provision of this document, the Corporation shall carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
