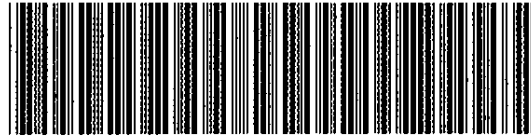

Article III:(A) The purpose for which the VOICES OF CONCERNED CITIZENS is organized are exclusively religious, charitable scientific, literary, and educational within the meaning of section 501 (c)(3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue Law. (B) Notwithstanding any other provision of these articles, this organization shall not carry any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue Law. (C) Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization, or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

VOICES OF CONCERNED CITIZENS, INC will also provide development services to citizens with criminal backgrounds, which extends employment opportunities beyond the minimum wage and high labor intensive arena for those citizens and others.
