## **ARTICLES OF INCORPORATION**

These articles of Incorporation are signed by the incorporators for the purpose of forming a non-profit corporation pursuant to the provisions of Chapter 617.0202, F.S.

### **ARTICLE I**

The name of the corporation shall be: Delta Eminence Foundation, Incorporated

### **ARTICLE II**

The principal street address and mailing address is: 1109 Coretta Way, Orlando, Florida 32805

### **ARTICLE III**

The purpose for which the corporation is organized is: to promote charitable literacy, and educational grant opportunities, including scholarships, benevolent and cultural, within the meaning of the Internal Revenue Code Section 501(c) (3). Included is the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Code of 1954. Said corporation is to be financed by donations and assessments from members of Delta Sigma Theta Sorority and by the general public. Acceptance of financial support from Federal, State, County Municipality and Township Government bodies is also allowed.

### **ARTICLE IV**

The manner in which the Directors are elected or appointed: Directors shall be appointed by a majority vote of the Directors currently serving on the Foundation Board of Directors. Criteria for selecting new Directors is determined by the By-Laws and governed as such.
