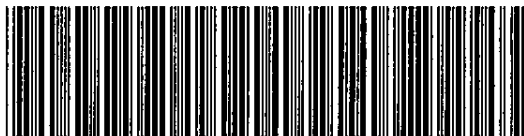

AMENDING ARTICLE III TO STATE:

ADDING ARTICLE XIX:

by a Court of Competent Jurisdiction of the county in which the principal office of the corporation
