**ARTICLES OF INCORPORATION**

**ARTICLE I - NAME**

The name of this corporation shall be First Baptist Church of Bushnell Daycare, Inc.

**ARTICLE II - ADDRESS**

This corporation's principal place of business shall be located at 125 West Anderson Ave, Bushnell, Florida 33513. This corporation's mailing address shall be 125 West Anderson Ave, Bushnell, Florida 33513.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of operating a not-for-profit Christian Child Daycare Center.

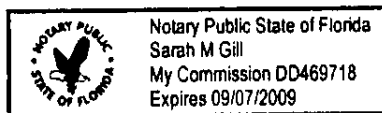




