TO
ARTICLES OF INCORPORATION
OF
N VISION COMMUNITIES, INC.
(Document Number N08000005421)

Pursuant to Section 617.1006, Florida Statutes, this corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. Subparagraph 3 to Article IV. Purposes shall be deleted in its entirety.
2. Article IV. Purposes shall read as follows:

(Words in ~~strike-through type~~ are deletions from existing text.)

1. To create, preserve, expand, rehabilitate, and otherwise enhance the number and quality of housing stock available to low and moderate income, elderly, disabled and handicapped persons.

2. To promote the health, education and welfare of the community and to receive and maintain real or personal property, or both, and subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or any part of the income therefrom and the principal thereof exclusively for charitable, religious, scientific, literary, or educational purposes either directly or by contributions to organizations that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

- ~~3. To expand the inventory of housing for very low, low and moderate individuals, families, elderly and disabled adults in the following named group of counties within the State of Florida: DeSoto, Highlands, and Okeechobee. The Corporation shall have a formal process for low income program beneficiaries to advise the Corporation in all of its decisions regarding the design, siting, development and management of all HOME assisted affordable housing. This formal process shall include special workshops with a committee of Advisors chosen by the Board of Directors which represents low income residents in areas of potential concern and development. The Corporation shall be free to contract for goods and services from vendors of its own choosing.~~
