On July 10, 2008 I, Valerie McFarlane reported my credit card stolen by Brian Deason. A report was filed with the Flagler County Sheriff's Office. The Office of the State Attorney, Seventh Judicial Circuit of Florida subsequently opened case number 08-00841-CFFA.

One of the items listed on my bank statement includes a charge for \$78.75 from FLORIDA CORP FILE-INTERNET. Mr. Deason opened a corporation named the Organ Donor Awareness Corporation. He listed my name as the registered agent and his name as the incorporator.

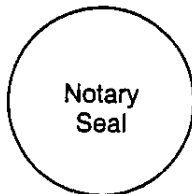
I had no knowledge of this transaction, nor was Mr. Deason given the authorization to use my name, address, and credit card for his corporation.

Another fraudulent charge is for Wilbarger County, Texas in the amount of \$757.90 and \$29.95. Mr. Deason received a speeding ticket in 2007 and he used my stolen credit card to pay for his ticket. At no time was he authorized to use my credit card to pay for this speeding ticket.
