The purpose for which the corporation is organized is:

A. The Corporation is organized exclusively for charitable, educational, religious, or specific purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code.

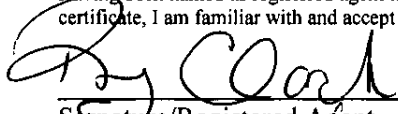

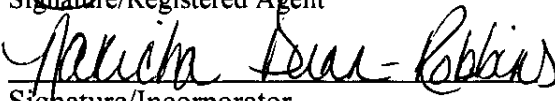
