
The period of duration of this corporation is perpetual.

QUALIFICATIONS OF MEMBERSHIP AND DIRECTORS:

Article 16 Indemnification

The Company shall not settle any action or claim in any manner which would impose any penalty or limitation on Indemnities without Indemnities; prior written consent.
