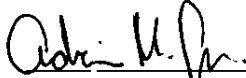

ARTICLES OF INCORPORATION

Anointed and Appointed Outreach, Inc.

- ONE: The name address of this principal corporation is Anointed and Appointed Outreach, Inc. 15511NW 135th Terr. Alachua, Fl. 32616. The corporation is organized pursuant to the Florida Nonprofit Code.
- TWO: This Corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of, but shall not be limited to: Child Care, Job Training, Job Placement, Land Acquisition Housing, Employment, Literacy, Mentoring, Counseling, Temporary Shelter, Teenage Pregnancy, Substance Abuse Awareness, sports and Prevention, Tutoring, AIDS, Health and Fitness, Elderly Care and other programs to aid those in need.
- THREE: The duration of this corporation shall be perpetual, stock and shall have other members.

- (a) This corporation is organized and operated exclusively for Religious, Charitable, Educational, and/or scientific purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code.
- (b) Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

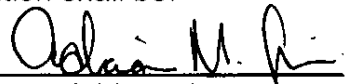

Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
