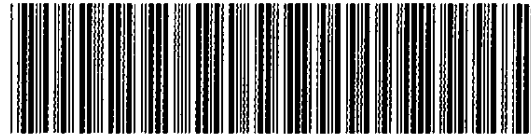



ARTICLE VIII CHARITABLE PURPOSES


