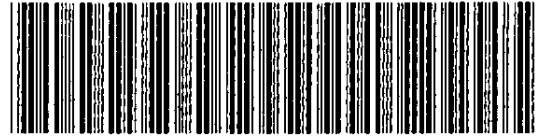

In Compliance with Chapter 617, F.S., (Not for-Profit)

ARTICLE I NAME
