Lifelong Learning Academy, Inc., a corporation not-for-profit, organized under the laws of the State of Florida (the "corporation"), having taken action to dissolve under the provisions of Section 617.1402, Florida Statutes, governing voluntary dissolution by consent of the Board of Directors, hereby files these Articles of Dissolution in accordance with Section 617.1403, Florida Statutes.

1. The name of the corporation as currently filed with the Florida Department of State is Lifelong Learning Academy, Inc.
2. The document number of the corporation is N08000005524.
3. The corporation does not have any members.
4. The Board of Directors of the corporation approved the plan of dissolution and a dissolution date of June 1, 2016 at its meeting on December 1, 2015. NOTICE OF CORPORATE DISSOLUTION


