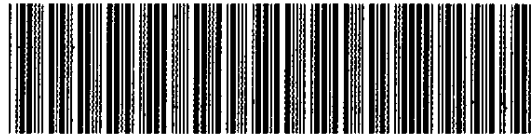

**ARTICLES OF INCORPORATION**  
**OF**  
**For the Girls International Incorporated**  
**A Florida "Not for Profit" Corporation**

The undersigned, acting as incorporators of a corporation under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation:

**Article 1 NAME OF CORPORATION:**

The name of the corporation is For the Girls International Incorporated

**Article 2 PRINCIPAL OFFICE AND MAILING ADDRESS:**

The principal office and mailing address of the corporation is located at 10312 Palladio Drive, Trinity, Florida 34655

**Article 3 CORPORATE PURPOSES:**

The Statement of Purpose for which the corporation is organized is:

To facilitate spiritual growth, personal development and leadership among women; encouraging them to engage in meeting the physical, emotional and spiritual needs of their families, their communities and the world.

The purposes for which this corporation is formed are exclusively charitable, religious and educational and consist of the following:

- a. This corporation is formed exclusively for charitable, religious and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue law."
- b. To aid, support, and assist by gifts, contributions, or otherwise, other corporations, community chests, funds and foundations organized and operated exclusively for religious, charitable or educational, no part of the net earnings of which inures to the benefit of any private shareholder or individual, and no substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation.
- c. To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, association, trusts, institution, foundations, or governmental bureaus, departments or agencies.
- d. All of the foregoing purposes shall be exercised exclusively charitable, religious and educational purposes in such a manner that the Corporation will qualify as an exempt organization under section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue law.

**Article 4 REGISTERED AGENT:**

**Article 5 MANNER OF ELECTION**

Vacancies can be created by resignations, removals, or an increase in the size of the board of directors. Vacancies on the Board of Directors can only be filled by a majority vote of the remaining Directors, though less than a quorum.

**Article 6 INITIAL BOARD OF DIRECTORS:**

The initial Board of Directors will be comprised of 7 members. The offices will be named in the bylaws. The names of the initial Board of Directors are:

The period of duration is perpetual.

**Article 9 ADDITIONAL PROVISIONS**

a. **CORPORATE PURPOSES:** Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal and state income tax under section 501 (c)(3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue law.

b. **EXCLUSIVITY:** The Corporation is organized exclusively for charitable, religious and educational purposes.

c. **NO PRIVATE INUREMENT:** The Corporation is not organized nor shall it be operated for the primary purpose of generating pecuniary gain or profit. The Corporation shall not distribute any gains, profits or dividends to the Directors, Officers, or Members thereof, or to any individual, except as reasonable compensation for services actually performed in carrying out the Corporation's charitable, religious and

educational purposes. The property, assets, profits and net income of the Corporation are irrevocably dedicated to charitable, religious and educational purposes no part of which shall inure to the benefit of any individual.

d. **LOBBYING AND POLITICAL CAMPAIGNS:** No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.

e. **DISSOLUTION:** Upon winding up and dissolution of the Corporation, the assets of the Corporation remaining after payment of all debts and liabilities shall be distributed to an organization recognized as exempt under section 501(c)(3) of the Internal Revenue Code to be used exclusively for charitable, religious and educational purposes. If the Corporation holds any assets in trust, such assets shall be disposed of in such a manner as may be directed by decree of the Circuit Court of the district in which the Corporation's principal office is located, upon petition thereof by the Attorney General or by any person concerned in the liquidation.
