ARTICLE I

The name of this corporation is **CHRIST CENTRAL ALACHUA, INC.**

ARTICLE II

The principal place of business 14557 NW US Highway 441, Alachua, Florida 32615 and mailing address of the corporation is Post Office Box 219, Alachua, Florida 32616.

ARTICLE III

This is a non-profit corporation organized solely for general charitable purposes pursuant to the Florida Corporations Not for Profit Law set forth in Chapter 617 of the Florida Statutes. The corporation shall begin its existence when filed and shall have a perpetual existence thereafter.

ARTICLE IV

The powers of this corporation shall be exercised and its properties controlled and its affairs conducted, by the Church and Pastor's Council. The number of council members of the corporation shall be not less than three (3) and not more than seven (7); provided, however, that such number may be changed by-laws duly adopted by the member of the corporation.

The council members named herein as the first Pastor's Council shall hold office until the first meeting of members for the purpose of electing new council members to

be held within six (6) months after the filing of these Articles of Incorporation at which time the new council members may be elected in their stead.

Council members shall serve for a term of not less than one (1) year and not more than two (2) years as set forth in the by-laws of the corporation. This shall not prohibit a council member from being elected to successive terms of office. The annual meeting for the corporation shall be held at the time and place set forth in the corporation by-laws.

ARTICLE V

The names and addresses of the first members of the Pastor's Council are as follows:

ARTICLE VI

The corporation shall have a membership distinct from the Pastor's Council. All members must be of the Christian faith and believe in God, and must be accepted for membership in the manner prescribed in the by-laws of the corporation. The authorized number, different classes of membership, if any, the property, voting and other rights

and privileges of the members and their obligations shall be set forth in the by-laws to be proposed by the Pastor's Council and accepted by a majority of the membership.

ARTICLE VII

The county in the State of Florida where the principal office for the transaction of the business of this corporation is to be located is Alachua County. The name and address of this corporation's registered agent is Tina R. Johns, 2151 SE County Road 245, Lake City, FL 32025.

ARTICLE VIII

The specific primary purposes for which this corporation is formed are to operate for the advancement of religion and for other charitable purposes by the distribution of its funds for such purposes and particularly for the furtherance of the Christian faith.

The general purposes for which this corporation is formed are to operate exclusively for such religious purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954 or corresponding provision of any subsequent federal tax laws, including for such purposes the making of distributions to organizations which qualify as tax exempt organizations under that code.

The corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these Articles, this corporation will not carry on any other activities not permitted to be carried on by:

- 1) A corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue law; or
- 2) A corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 or any other corresponding provision of any future United States Internal Revenue law.

Upon the dissolution or winding up of this corporation, its assets remaining after payment or provision for payment of all debts and liabilities of the corporation shall be distributed to another organization which is organized and operated exclusively for religious purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provisions of any subsequent federal tax laws as determined by the Pastor's Council.

ARTICLES IX

Amendments to these Articles of Incorporation may be proposed by a resolution adopted by the Pastor's Council and presented to a quorum of members for their vote. Amendments may be adopted by the vote of two-thirds of a quorum of members of the corporation.

We the undersigned, being the incorporators of this corporation and including all the persons herein named as the subscribers of this corporation, for the purpose of forming this non-profit charitable corporation under the laws of Florida, have executed these Articles of Incorporation the day and year set opposite our names.

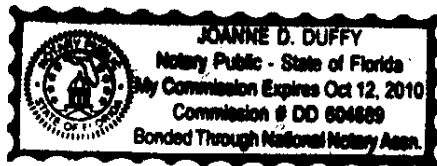
