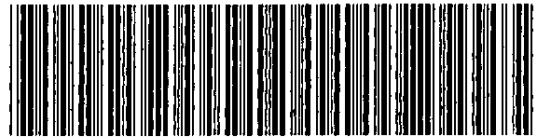

### **Article III Purpose**

Global Toddler Inc is organized for charitable and educational purposes, to help African women and organizations make suitable products for the global export market and help them find a global market for their products. The aim is to help women in countries with a hungry season improve their incomes and feed their families, and open up their microenterprises to global e-commerce opportunities.

No part of the earnings of Global Toddler shall inure to the benefit of its directors or officers except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments in furtherance of the purposes stated above.

No substantial part of the activities shall be the carrying on of propaganda to influence legislation. The corporation shall not carry on activities not permitted by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code.

Upon the dissolution of the corporation, remaining assets shall be distributed for one or more exempt purposes within the meaning of section 501 © (3) of the Internal Revenue code, or the corresponding section of any future federal tax code.
