ARTICLES I - NAME

The name of the corporation is Helping Underprivileged Residents Develop Lifelong Everyday Skills Inc., and a Florida corporation not for profit.

ARTICLE II – PRINCIPAL OFFICE

ARTICLE III- PURPOSES

**The specific purposes for which this corporation is organized are:

**The corporation shall issue no stock. No part of the net earning of this corporation shall inure to the benefits of or be distributed to its members, directors, officers or other private persons except that this corporation shall authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this article. No substantial part of the activities of influence legislation. This corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, including the publishing or distribution of statements. Notwithstanding any other provision of these articles, this corporation exempt from federal income tax under Section 501© (3) of the Internal Revenue Law. On dissolution of this corporation the board of directors shall dispose of all the assets of this corporation exclusively for charitable, educational, religious or scientific purposes and which shall at the time qualify as exempt under Section 501 © (3) of the Internal Revenue Code of 1954 or corresponding provisions of any future United States Internal Revenue Law, after paying or making provision for the payment of all liabilities of this corporation. Any assets not so disposed of by a court of competent jurisdiction in the purposes or to the organizations that the court
Determines are organized and operated exclusively for charitable, educational, religious or scientific purposes.**
