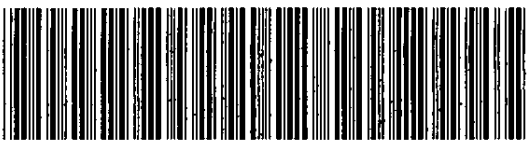

**Articles of Incorporation Art Quilters Unlimited, Incorporated**  
In compliance with Chapter 617, F. S. (Not for Profit)

**ARTICLE I NAME**

The name of the corporation shall be Art Quilters Unlimited, Incorporated.

**ARTICLE II PRINCIPAL OFFICE**

The principal place of business for the corporation shall be 10091 McGregor Blvd, Fort Myers, FL 33919. The principal mailing address of the corporation shall be 2510 SW 37<sup>th</sup> Street, Cape Coral, FL 33914.

**ARTICLE III PURPOSE**

The purpose for which Art Quilters Unlimited, Incorporated is organized shall be to promote, encourage and develop a creative environment for fiber artists of all levels of expertise and to inspire and support one another through Education and sharing the creative process.

**ARTICLE IV MEETINGS**
