**ARTICLE I NAME**

**ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

The purpose of Saint Faustina Old Catholic Church, INC. is to be a place of worship and Christian community within and adhering to the beliefs, practices, dogmas and liturgy of the Old Catholic Church.

The principle function of Saint Faustina Old Catholic Church, INC. is the celebration of the Holy Sacrifice of the Mass on Sundays and High Holy Days of religious obligation. Alongside this we are dedicated to the community of Pensacola by contributing, as best we can, through charitable acts of kindness such as feeding and clothing the homeless.

**ARTICLE IV MANNER OF ELECTION**

The manner in which the directors are elected or appointed:

Our church (parish) is under the Archbishop Wayne Boosahda and in communion with the Diocese of Saint Patrick. This parish will be staffed by priests and deacons who are members in good standing with the Society of Saint Patrick and Saint Aidan which is an Old Catholic religious order.

Priests and deacons are selected by the Bishops sometimes with the recommendation of the parish. The Bishops review the names, qualifications, applications, etc. and determine the best candidate.

The Bishop or his successor has the right, according to his office, to over ride any vote made by the parish counsel in the event that such a vote were to go against the rules, practices, beliefs or dogmas of the One, Holy, Catholic and Apostolic Church.




