Article III – Purpose

Section 1. The purpose of FastFood Ministry, Inc. is to help facilitate the distribution of monetary resources to non-profit organizations both national and international, which are helping to alleviate hunger, poverty, and social injustice.

Section 2. The organization is organized exclusively for charitable, religious, educational, and scientific purposes including for such purposes the making of distributions to organizations that qualify as exempt organizations under section 501c3 of the Internal Revenue Code or corresponding section of any future federal tax code.

Article IX - DISSOLUTION

In the event of dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501c3 of the Internal Revenue Code or corresponding section of any future federal tax code or shall be distributed to the federal government or to a state or local government for a public purpose. Any such asset not disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principle office of the organization is then located exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purpose.
