ARTICLES OF INCORPORATION OF

MACEDONIA AFRICAN METHODIST EPISCOPAL CHURCH, INC.

(Not for Profit)

The Undersigned, a Majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation law of the State of Florida, PURSANT to Florida Statutes, and do hear by adopt the following Articles of Incorporation for such Corporation, Do hear by certify:

ARTICLE ONE

The name of the corporation shall be:

Macedonia African Methodist Episcopal Church, Inc.

ARTICLE TWO

The Place in this State where the principal office of the corporation is to be located in the reity of Fernandina Beach, Florida and the County of Nassau:

202 South 9th Street Fernandina Beach, Florida 32034

ARTICLE THREE

The Specific purpose for which the corporation is organized is:

Said Corporation is organized exclusively for Charitable, Educational, Scientific and Religious purposes. Including, encouraging religious worship in accordance with the principles of the African Methodist Episcopal Church. That it shall purchase, take, receive, lease take by gift, devise or bequest, or otherwise acquire, own, hold, improve, use, or otherwise deal in and with real or personal property, or any interest therein whenever situated, in trust for the use and benefit of the African Methodist Episcopal Church. It shall have the right to make conveyance of its property in accordance with the rules of the general body of the African Methodist Episcopal Church and the current edition of the "The Doctrine and Discipline of the African Methodist Episcopal Church"; it being understood that said corporation shall not be required to accept any such donations or gifts not in harmony with the purpose and object of said corporation.

ARTICLE FOUR

The term of existence of the corporation is as follows:

The corporation shall have perpetual existence, unless it becomes in conflict with the laws of the African Methodist Episcopal Church as found in the current edition of the "The Doctrine and Discipline of the African Methodist Episcopal Church" and is dissolved in the manner provided by law. In the event of dissolution of the corporation and after the payment of all debts, and monies or assets remaining shall not inure to benefit of any individual, but shall be held in trust by The East Conference of the Eleventh Episcopal District of the African Methodist Episcopal Church, Inc.

The manner in which the Board of Trustees and the Directors shall be appointed is as follows:

The Board of Trustees and Directors shall be appointed in accordance with the current edition of "The. Doctrine and Discipline of the African Methodist Episcopal Church".

This not for Profit Corporation shall indemnify any officer or Director, adviser to the full extent permitted by law and reserves the right to amend or repeal any provision contained in these articles or amendments hear to.
