Article I - Name

The name of the corporation shall be Voight Foundation, Inc.

Article II – Principle Office

Article III - Purpose

The purpose for which the corporation is organized is to build a sense of community by providing community based events, educational scholarships and grants.

Article IV – Prohibited Activities

Notwithstanding any other provision of these Articles of Incorporation, this corporation will not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(C)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provisions of any future United States Internal Revenue law, or a corporation to which contributions are deductible under Section 170(C)(2) of the Internal Revenue Code of 1986, as amended, or the corresponding provisions of any future United States Internal Revenue law.

Article V - Manner of Election

The officers of the corporation will consist of:

- Final/Executive Decision Making Officers called the Governing Board of Directors
 - o Founder
 - o Chairman
 - o Vice Chairman
 - o Treasurer
 - Secretary

The Founder shall remain as a life officer (until death) with all veto power and shall appoint all Governing Board of Directors on an annual basis.

- Day-to-Day Operating Officers
 - Chief Executive Officer (also known as President or Executive Director)
 - o Chief Financial Officer
 - o Chief Operations Officer
 - Chief Human Resources Officer (also known as Chief of Staff)
 - Executive Assistant to Chief Officers
 - Fund Development Manager

They shall be elected annually by the Governing Board of Directors. All terms of office shall be for one year. Nominations for officers may be made from the floor by any member. When there is only one candidate for each office, the election is by acclamation. When more than one candidate for any office exists, the election shall be by ballot and a majority of those voting shall elect. Vacancies in office may be filled at any regular meeting in the above manner.
