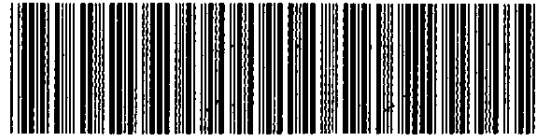



**Articles of Incorporation**

**Article I**

The name of the Corporation shall be: SEAID INC.

**Article II**

The principal place of business and mailing address of this Corporation shall be:

**Article III**

SEAID INC. is a PUBLIC BENEFIT nonprofit corporation that is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, including, for such purposes, the making of distributions to organizations that qualify as tax-exempt organizations under Section 501(c)(3) of the Internal Revenue Code. Specifically, this nonprofit corporation is organized and operated to spread awareness and consciousness about the importance of sustaining a healthy and diverse marine ecosystem, which is beneficial for improving water quality, protecting distinct marine habitat, and enhancing the quality of life for coastal communities, to educate individuals about various shark, dolphin, turtle and whale species and their status, and to provide invaluable information to divers, young adults, as well as the public at large about new and innovative approaches to marine conservation.

**Article IV**

The manner in which the directors are elected or appointed: During the annual meeting, the officers shall elect the directors of the Corporation.




## Article VII

**Purpose of Obtaining 501(c)(3) Tax-Exempt Status:** No part of the net earning of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code, or corresponding provisions of any future United States Internal Revenue Code.

**Dissolution:** Upon the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable or educational purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.
