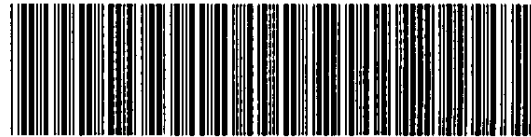

Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendment(s) to its Articles of Incorporation:

AMENDMENT(S) ADOPTED

Article Number VI: Amendment of title of Board of Trustee

Article VI

~~The Board of Trustee of this corporation shall be called the Ministerial Board.~~ The power of this corporation shall be exercised, its properties controlled, and its affairs conducted by the **Board of Trustee Ministerial Board**. The number of members of the **Board of Trustee Ministerial Board** of this corporation shall be three, provided, however, that such number may be changed by a Bylaw duly adopted by the **Board of Trustee Ministerial Board**, which shall never be less than three. The manner of election shall be as provided in the by laws.

Article Number VIII: Amendment of title of Board of Trustee

Article VIII

Upon dissolution of the corporation, the **Board of Trustee Ministerial Board** shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the

Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the **Board of Trustee Ministerial Board** shall determine. Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction in the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as such Court shall determine, which are organized and operated exclusively for such purposes.

Article Number X: Amendment of title of Board of Trustee

Article X

Subject to the limitations contained in the Bylaws, and any limitations set forth in the Corporations Not For Profit Law of the State of Florida concerning corporate action that must be authorized or approved by the **Board of Trustee Ministerial Board** Bylaws of this corporation may be made, altered, rescinded, added to, or new Bylaws may be adopted, either by a resolution of the **Board of Trustee Ministerial Board**, or by following the procedures set forth therefore in the Bylaws.

Article Number XI: Amendment of title of Board of Trustee

Article XI

Amendments to these Articles of Incorporation may be proposed by a resolution adopted by the **Board of Trustee Ministerial Board** and presented to a quorum of the Board's members for vote.
