**ARTICLES OF INCORPORATION  
OF  
CONSERVATIVE REPUBLICAN ALLIANCE FOUNDATION INC.**

The undersigned, a natural person of the age of eighteen years or more, acting as the sole incorporator of a corporation under the provisions of the Florida Not for Profit Corporation Act (the "Act"), adopts the following Articles of Incorporation:

**ARTICLE I**

The name of the corporation is Conservative Republican Alliance Foundation Inc.

**ARTICLE II**

The street address of the initial principal office of the corporation is 20400 West Country Club Drive, Suite 118, Aventura, Florida, 33180.

**ARTICLE III**

This nonprofit corporation is organized and operated exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations within the meaning of § 501(c)(3) of the Internal Revenue Code. In furtherance thereof, the Corporation may receive property by gift, devise or bequest, invest and reinvest the same, and apply the income and principal thereof, as the board of directors may from time to time determine, either directly or through contributions to any charitable organization or organizations, exclusively for charitable, or educational purposes, and engage in any lawful act or activity for which corporations may be organized under the Act.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. No substantial part of the activities of this corporation shall be for the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The Corporation shall comply with the laws, rules and regulations set forth in and promulgated pursuant to the Code which are applicable to organizations described in Section 501(c)(3) of the Code, to which contributions are deductible under Section 170(c)(2) of the Code or the corresponding section of any future federal tax code.

**ARTICLE IV**

The election of directors shall be as stated in the bylaws of the corporation.

The street address of the corporation's registered office is 20400 West Country Club Drive, Suite 118, Aventura, Florida, 33180, and the name of the corporation's registered agent at that address is Javier Manjarres.

## ARTICLE VI

The number of directors constituting the board of directors of the corporation shall not be less than three. The number of directors constituting the initial board of directors shall be three. From time to time hereafter, the number of directors shall be fixed exclusively pursuant to a resolution adopted by the affirmative vote of a majority of the board of directors of the corporation.
