ARTICLE I NAME

ARTICLE II PURPOSE

The main purpose of the Foundation Luisi H. Alvarez, Corp., is to carry on with activities related with abandoned children, to give them shelter, general care and studies. The general purpose for which this corporation is formed is to operate exclusively for such explained activities; taking care of children, giving them shelter, general care and studies as will qualify it as an exempt educational organization under Section 501 (c)(3) of the internal revenue code of 1986 or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that Code. This corporation has, and shall continue to have, a racially nondiscriminatory policy as to students and shall not discriminate against applicants and students on the basis of race, color or national or ethnic origins.


