ARTICLES OF INCORPORATION

OF

ARTICLE I NAME

The name of this corporation shall be WILDWOOD ATHLETIC CLUB, INC.

ARTICLE II PRINCIPAL OFFICE

The address of the principal office of the corporation is 9195 CR 128D Wildwood, Fl 34785, and the mailing address is the same.

ARTICLE III PURPOSE

This corporation is organized for the following purposes:

(e) Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code as it now exists or as amended in the future.
