Article I Name Tony Parker Ministries, Inc.

Article IV Purpose

This is a not for profit corporation organized for religious, educational and charitable purposes pursuant to the Florida Corporation Not For Profit law set forth in Section 617 of the Florida Statutes. The term of existence of the corporation is perpetual.

The overall purpose of *Tony Parker Ministries*, *Inc.* as a faith based organization established to form a fellowship ministry based on Biblical principals which will serve as a guiding pillar for the mutual sharing of the good news of the Gospel of Jesus Christ:

- a. Providing Biblical training and education through teaching, preaching, evangelism.
- b. Networking information and reference/resource sharing capacity building and helping to provide a positive voice for the churches within various public venues.
- c. Programs which strengthen the family by establishing family as top priority in people lives and by promoting principles for building marriages and raising children.
- d. Minister and provide counseling and resources to individuals being released from local, state and federal correctional facilities.
- e. Establish internal and external development programs of assistance and/or programs to meet the spiritual, emotional, physical and material needs of members and/or non-members as determined necessary and needful in accordance with the Gospel teaching of Jesus Christ.

- f. Said organization is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organization that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- g. No part of the net earnings of the organization shall insure to the benefit of, or be distributed to its members, trustees, officers, or private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for the services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.
- h. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
- i. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt for federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by any organization, contribution to which are deductible under section 170 (c) (2) of the Internal Revenue Code or corresponding section of any future tax code.
- j. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes with in the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a stare or local government, for a public purpose.
- k. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the country in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purpose.

Article V The Manner of Election

The Board of Directors is initially and henceforth appointed by the Founder/President of the Board. The manner in which the Board of Directors is appointed shall be determined by the Founder/President and that determination is set forth to include:

- A) Persons who believe in repentance towards God and faith in JESUS CHRIST as their savior and LORD and follow him in baptism and to observe the ordinance of CHRIST and to be governed by His laws are qualified and eligible for membership in this ministry.
- B) The appointment of no less than three and no more than five members to serve a team of one year on the *Tony Parker Ministries, Inc.* committee.

- C) The appointment of members to the Board is to based on the individuals ability to contribute in terms of providing suggestions, information an qualifications as deemed appropriate and necessary by the President.
- D) The understanding of each Board member is that their services are in an appointed capacity and that they may be terminated at any time without written or verbal advance notifications by the President.
- E) The understanding of each Board member is that their position is in an advisory capacity for the promotion, maintenance and sustaining of the corporation.
- F) Decisions that are requested of the Board by the President will be made by majority vote and provided to the President for a recommendation.
- G) The President will hold the ultimate decision upon forwarding of recommendations by the Board of Directors.
