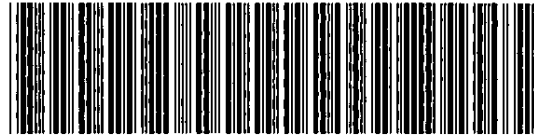

**ARTICLES OF INCORPORATION

The undersigned incorporators, for the purpose of forming a corporation under the Florida Not For Profit Corporations Act, hereby adopt the following Articles of Incorporation.

**ARTICLE I  
NAME**

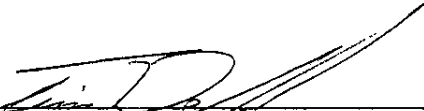
