ARTICLES OF INCORPORATION **OF**

TO SERVING SER COMMUNITY IMPROVEMENT INITIATIVES, INC.

The undersigned associate for the purpose of becoming a not for profit corporation under Chapter 617, laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a not for profit corporation.

ARTICLE I

NAME

The name of the not for profit corporation shall be Community Improvement Initiatives, Inc.

<u>ARTICLE II</u>

PRINCIPAL PLACE OF BUSINESS

The address of the initial principal place of business shall be 2609 Sunrise Ridge Lane, Jacksonville, Florida 32211.

<u>ARTICLE III</u>

PURPOSE

This not for profit is organized exclusively for charitable and educational purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1996 or the successor provision of any future United States Internal Revenue Law. The purpose of the association shall be to improve the quality of life of ex-convicts thereby making them useful to the Jacksonville community, helping dropouts find a vocation that matches their interest, and counseling youths and minors involved in drugs or any addiction. This purpose shall be promoted by, but not limited to, communications, meetings, prison house visits, conference, workshops, special projects, leadership development, and hands on training. Special effort shall be made to identify with kids, teens, and other youths in residential areas lacking governmental attention, and areas with poor quality of lives in Jacksonville, Florida. To disseminate information about the critical needs to help youths and adults after serving jail terms to find their feet and be useful to the Jacksonville Community as opposed to neglecting and rejecting them based on their past mistakes.

To assist college dropouts and other uneducated youths in getting into a vocation that will help them contribute to the development of the Jacksonville community.

Helping addicts overcome their addictions through religious and non-religious exercises that are channeled towards saving lives of addiction.

To the end that the forgoing objectives and purposes and any related religious and charitable purposes may be carried out, performed and accomplished, this corporation shall have the power to engage only in such activities as shall not constitute business related to its charitable and educational purposes. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501 (c)(3) of the Internal Revenue Code of 1996 or the successor provision of any future United States Internal Revenue Law. Subject to the foregoing limitations, this corporation shall have all of the rights and powers set forth in Section 617.0302, Florida Statutes.

<u>ARTICLE IV</u>

MANNER OF ELECTION OF DIRECTORS

The method or manner of the election of the Board of Directors shall be stated in the corporate by-laws.
