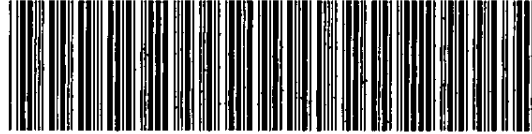

ARTICLES OF INCORPORATION  
OF  
MOUND STREET CHRISTIAN ACADEMY, INC.

---

The undersigned, acting as incorporator of a non-profit corporation under the Not for Profit Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I – NAME

The name of the corporation is MOUND STREET CHRISTIAN ACADEMY, INC.

ARTICLE II – TERM OF EXISTENCE

The period of duration of the corporation is perpetual.

ARTICLE III – NATURE OF BUSINESS

This corporation is organized for the following purposes:

1. To provide Christian education.
2. To enhance students in the development of their spiritual and academic lives.
3. Teach students to show respect for God and Country in their everyday lives and to develop a good lifestyle.
4. To encourage young people of every faith to be good and productive citizens and make a meaningful contribution to society.
5. To teach students to maximize their participation in society and to benefit spiritually, culturally and academically from all things that God has made.
6. To take charge of, hold and manage all property, real and personal, that may at any time or in any manner come to or vest in this corporation for any purposes whatsoever, whether by purchase, gift, grant, devise or otherwise, and to mortgage, sell or otherwise dispose of such property as the necessities of the corporation may require; and

7. To engage in any other activities which are lawful in the State of Florida and the United States of America for non-profit corporations.

#### ARTICLE IV – MEMBERSHIP

The Qualifications for membership and the manner of admission shall be as regulated by the By-laws.

#### ARTICLE V – INITIAL REGISTERED OFFICE AND AGENT

The principal place of business of the corporation is 1920 Mound Street, Orange Park, Florida 32073. The name of the initial registered agent is BURNEY BIVENS, and the address of the initial registered agent is 1543 Kingsley Avenue, Suite 18-B, Orange Park, Florida 32073.

#### ARTICLE VI – DIRECTORS

The initial Board of Directors shall consist of five (5) members who need not be residents of the State of Florida.

#### ARTICLE VII – INITIAL DIRECTORS

#### ARTICLE IX – DUTIES AND POWERS

MOUND STREET CHRISTIAN ACADEMY, INC., shall be a non-profit corporation and shall have all the duties and powers of non-profit organizations, and no member, officer or director shall be authorized to do anything inconsistent with a non-profit corporation. No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III. No substantial part of any of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code; or a corporation, contributions to which are

deductible under Section 170(c)(2) of the Internal Revenue Code or the corresponding section of any future federal tax code.

#### ARTICLE X – AMENDMENT OF ARTICLES OF INCORPORATION

The members shall have the power to adopt, amend, alter, change or repeal the Articles of Incorporation when proposed and approved at a called membership meeting, with not less than a two-thirds vote of the members.

#### ARTICLE IX – STOCK

The corporation is organized and shall be operated on a non-stock basis within the meaning of the Florida Not For Profit Corporation Act and shall not have the power to issue shares of any type or class of stock but may issue membership certificates if so provided in the by-laws.

#### ARTICLE XII – DISSOLUTION OR CORPORATION

Upon dissolution of the corporation, the assets of the corporation remaining after payment of all debts and liabilities of the corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code or shall be distributed to St. John Missionary Baptist Church, Inc.

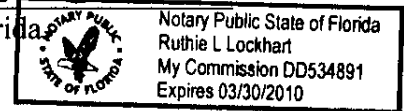
