The undersigned do hereby associate for the purpose of becoming a not for profit corporation under the laws of the State of Florida, and do hereby certify that the following Articles of Incorporation have been adopted:

**ARTICLE I**

The name of the corporation is **DIERCTIONS, INC.**

**ARTICLE II**

The street address of the initial registered office of this corporation is 1561 Crabapple Cove Court North, Jacksonville, FL 32225 and the name of the initial registered agent at that address is Loutricia Gibbs-Tolbert. The principal office address and mailing address of this corporation is 1561 Crabapple Cove Court North, Jacksonville, FL 32225.

**ARTICLE III**

This corporation has the purpose or powers as may be stated in these articles of incorporation, and such additional purposes or powers as may be granted hereafter.

The primary purpose of this corporation is:

1. To form a community outreach ministry to positively change the lives of young people through various programs to inspire them and direct them into productive lifestyles.
2. To provide training classes to enrich the lives of individuals and families by providing instruction in resume writing, job seeking skills, money management and starting businesses.

3. To utilize the arts to provide positive recreational activities to keep young people off the streets.

#### ARTICLE IV

The corporation shall have six (6) directors initially. The number of directors may be increased or decreased from time to time by majority vote of the association officers, but shall never be less than (3). 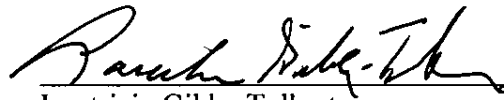

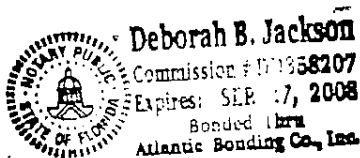
