I am one of two members of a two unit land condominium (former duplex) located in Holmes Beach Florida known as: Casa Del Mare IV Condominium Association, Inc.

On January 17, 2012 I utilized [www.sunbiz.org](http://www.sunbiz.org) to reinstate my association and inadvertently selected the wrong company to reinstate. I selected Casa Del Mare VI Condominium Association, Inc., Document Number N08000006330; mistaking the Roman numeral 6 for a 4. I paid the \$420 fee to reinstate using my credit card and received acknowledgement of the reinstatement via email on January 19, 2012.
