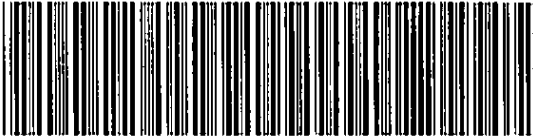

LICENSING AND ORDINATION

The purpose of this article is to establish the licensing and ordination procedures for ministers of Synergy Community

Development, Inc. Any person who gives evidence of a genuine call of God into the work of the ministry and demonstrate

faith in Ephesians 4:12 may be considered for licensing and ordination by Synergy Community Development, Inc.

Licenses issued by Synergy Community Development, Inc. are valid for one year from the date issued. Ordinations have

no expiration date. In accordance with the teachings of Scripture in Romans 1:25-27 and I Corinthians 6:9-11,

Synergy Community Development, Inc. does not ordain homosexuals.

1. Principles of Licensing and Ordination: The calling of a minister is not the result of a title but rather the title is the result of

The calling is recognized as from the true and living God. The licensed / ordained minister has the right to perform

ministerial functions in accordance with the laws of the land and the Word of God.

2. Licensing and Ordination Criteria: An applicant must be at least 18 years of age.

3. Procedures for Licensing and Ordination:

a. Application with Fee: An application must be completed and submitted to the Board of Directors along with a \$1.00 fee.

b. Exam: The applicant must complete an exam administered by the Board of Directors and pass with a minimum of 70%

c. Interview: After completing the application and exam, the applicant shall be interviewed by the Board of Directors.

d. Vote: The Board of Directors shall vote to grant the license or ordination. The vote must be unanimous.

4. Commissioning:

a. Notification: All candidates shall be notified of the Board's decision within one week of the final decision.

b. Certification: Each successful candidate shall receive a certification issued by the Board of Directors.

c. Prayer: Members of the body pray over the minister.

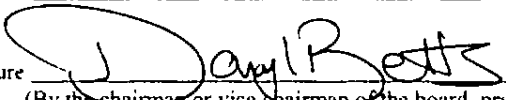
