# ARTICLES OF INCORPORATION OF REVELATION MESSAGE CHRISTIAN INSTITUTE, *INC.* A FLORIDA NONPROFIT CORPORATION

**Article 1. Name.** The name of the Corporation is:

Revelation Message Christian Institute, Inc.

**Article 2. Duration.** The duration of the Corporation is perpetual unless dissolved according to law.

**Article 3. Purposes.** The purpose for which the corporation is organized are as follows:

A. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are:

- 1.) To function as a school (Christian Institute) for the purpose of teaching Christians in matters pertaining to the furtherance of the Gospel message.
- 2.) To prepare individuals for ordination into the ministry.
- 3.) To provide a defined framework through which the ongoing ministry of Jesus may be propagated throughout the world.
- 4.) Any other purposes as may be defined by the BOARD OF DIRECTORS of REVELATION MESSAGE CHRISTIAN INSTITUTE, INC. that would be in concert with normal ministry functions in the Christian Evangelical community.

B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

**Article 4. Members.** At the time of incorporation, no membership qualifications are either established or expected. Should membership parameters be established, it will subsequently be stated in the by-laws.

**Article 5. Initial Registered and Office.** The initial registered agent is Fabienne Naomi-Smith and the initial registered office 7304 Elvia Dr. Jacksonville, Florida 32211.

**Article 6. Initial Board of Directors.** The initial Board of Directors shall have four members whose names and addresses are:

The Bylaws shall provide the method of election of all Directors, and the number of Directors may be raised or lowered by amendment of the bylaws but shall in no case be less than three.

**Article 7. Board of Advisors.** A Board of Advisors shall be established and consist of members to be appointed by the Board of Directors. The Board of Advisors is to function in an advisory capacity. Qualifications, term of service, and other pertinent matters concerning the discharge of their duties will be included in the by-laws of this corporation.

**Article 8. Incorporators.** The names and addresses of the incorporators of this corporation are:

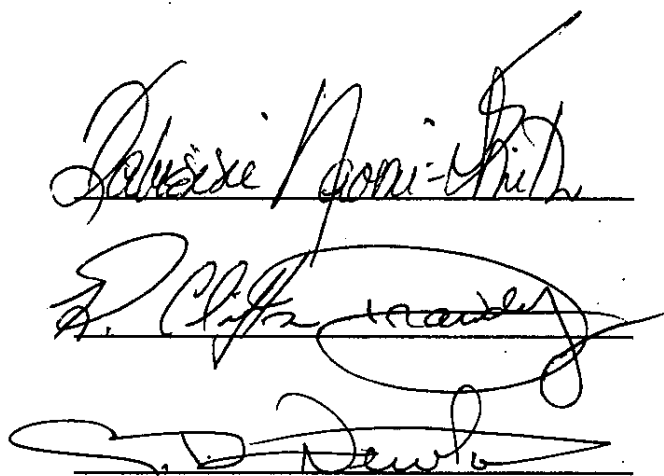

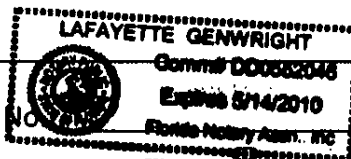

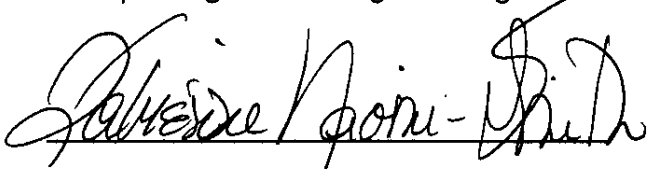
