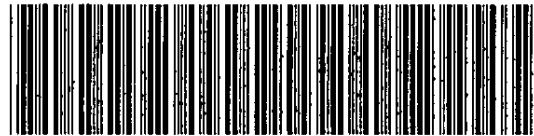

Article I NAME

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. No part of the net earnings of the organization shall inure to the benefit or, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay personable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on:

- (a) by an organization exempt from federal income tax under section 501(c)3 or the Internal Revenue Code, or corresponding section of any future federal tax code, or
- (b) by an organization, contributions to which are deductible under section 170(c)2 of the Internal Revenue Code, or corresponding section of any future federal tax code.

The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantage individuals and families towards a life of self-sufficiency. The programs will consist of, but shall not be limited to: Job Training, Job Placement, Employment, Land Acquisition, Community Development, Community Redevelopment, Housing, Temporary Shelter, Counseling, Teenage Pregnancy, Substance Abuse Awareness and Prevention, Literacy, Tutoring, AIDS, Elderly Care, Child Care, Performing Arts, Literary Arts, Visual Arts, and other programs to aid those in need.
