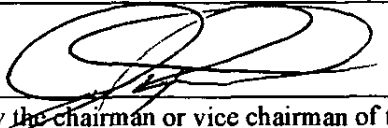

Articles to be added.

Said corporation/organization is organized exclusively for the charitable and religious purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501c3 of the Internal Revenue Code, or the corresponding section of any future federal tax code

No part of the net earnings of the corporation/organization shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation/organizations shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of section 501c3 purposes. No substantial part of the activities of the corporation/organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation/organization shall not carry on any other activities not permitted to be carried on (a) by a corporation/organization exempt from Federal income tax under section 501c3 of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation/organization, contributions to which are deductible under section 170c2 of the Internal Revenue code, or the corresponding section of any future federal tax code.

Upon the dissolution of this corporation/organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501c3 of the Internal Revenue Code. Or the corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
