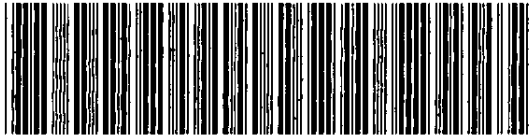

I, the undersigned, acting as the incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation of such corporation.

ARTICLE I

The name of the corporation shall be Both Eyes-Arrive Alive, Inc. The principal place of business of this corporation shall be 4519 Highway 90, Pace, FL 32571.

ARTICLE II

The period of the duration of this corporation is perpetual unless dissolved according to law.

ARTICLE III

The purpose of the corporation shall be

- to promote healthcare, education, safety, and research awareness regarding cell phone usage while driving;
- to keep families safe; and
- to provide such other and necessary services as needed to affect the above purposes.

All funds, whether income or principal and whether acquired by gift, contribution, or otherwise, shall be devoted to said purposes and those set forth by future directives.

The Corporation shall be organized exclusively for the charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or

hereafter amended, including for such purposes the making of distributions to organizations that also qualify as Section 501(c)(3) exempt organizations.

#### ARTICLE IV

Membership may be granted to any individual or corporation that supports the mission and purposes of the organization and who pays the annual dues as set by the Board of Directors.

Members shall have no voting rights.

#### ARTICLE V

The number constituting the initial Board of Directors of the corporation is one (1), and the names and addresses of the persons who are to serve initially are:

There shall always be a minimum of one (1) Director, and so many additional as the Board of Directors may from time to time establish. The Directors shall be elected pursuant to the By-Laws.

#### ARTICLE VI

This corporation is organized under a non-stock basis as a Florida not-for-profit corporation.

#### ARTICLE VII

In the event of dissolution, the residual assets of the organizations will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501 (c)(4) and 170 (c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior to future law, or to the Federal, State, or Local Government for exclusive public purpose.

ARTICLE VIII

ARTICLE IX

Every director and every officer of the corporation will be indemnified by the corporation to the fullest extent permitted by the Florida Nonprofit Corporation Law against all expenses and liabilities, including legal fees reasonably incurred by the imposed upon him or her in connection with any proceeding or any settlement of any proceeding to which he or she may be a party or in which he or she may become involved by reason of being or having been a director or officer at the time such expenses are incurred, except when the director or duties. Provided that in the event of a settlement, indemnification will apply only in the event that the Board of Directors approves such settlement and reimbursement as being in the best interest of the Corporation. The foregoing right of indemnification will be in addition to and not exclusive of all other rights to which such director and officer may be entitled.


