ARTICLES OF INCORPORATION OF

STATE CORPORATION COMMISSION: TO:

> The undersigned natural person of the age of twenty-one years or more, acting as incorporator, adopts the following Articles of Incorporation pursuant to the State Nonstock Corporations Act:

FIRST: The name of the corporation is: TREADWAY ELEMENTARY SCHOOL PTO, INC., 10619 Treadway School Road, Leesburg, Fl.

34788, Phone No. 352-742-2291.

SECOND: The Corporation is organized and will be operated exclusively for charitable and educational purposes within the meaning of 501(c) (3) of the Internal Revenue Code. (All references to sections in these Articles refer to the Internal Revenue Code of 1986 as amended or to comparable sections of subsequent internal revenue laws.)
