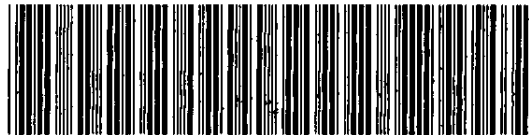

## **ARTICLES OF INCORPORATION**

### **OF**

### **HARVESTERS EVANGELISM MINISTRIES, INC.**

The undersigned incorporators, natural persons, 18 years of age or older, in order to form a corporate entity adopt the following articles of incorporation.

#### **ARTICLE I**

##### **NAME**

The name of this corporation shall be **HARVESTERS EVANGELISM MINISTRIES, INC.**

#### **ARTICLE II**

##### **PRINCIPAL OFFICE**

The Principal Office shall be 1147 Oak Hill Street, Seffner, Florida, 33584

#### **ARTICLE III**

##### **PURPOSE**

This corporation is organized exclusively for charitable, religious and educational purposes. To this end, the corporation shall at all times be operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

#### **ARTICLE IV**

##### **MANAGEMENT OF CORPORATE AFFAIRS**

The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of directors. The number of directors of the corporation shall be a minimum of three (3); provided, however, that such number may be changed by a bylaw duly adopted by the members, but never less than three.

The initial directors named in ARTICLE V shall hold office until the first annual meeting of members to take place after incorporation. Prior to that meeting, an election of directors shall take place, according to provisions of the bylaws of the corporation.

Directors elected in the first election, and at all times thereafter, shall serve for a term of 1 year; except that the bylaws may provide for a different term of office for some of the directors elected in the first election following incorporation, in order to introduce a system of staggered terms for directors.

## ARTICLE V

### BOARD OF DIRECTORS

The corporation shall have one or more classes of members, as provided in the corporation's bylaws. The management of the affairs of the corporation shall be vested in a Board of Directors, as defined in the corporation's bylaws. No Director shall have any right, title, or interest in or to any property of the corporation.
