**ARTICLES OF INCORPORATION**  
In Compliance with Chapter 617, F.S., (Not for Profit)

**ARTICLE I: Name**

The name of the corporation shall be: Sisters of Sound, Inc.

**ARTICLE II: Principal Office**

The principal place of business and mailing address of this corporation shall be:  
17417 Woodfair Dr. Clermont, FL. 34711

**ARTICLE III: Purpose**

The purpose for which the corporation is organized is:

- A. to educate its members in the art of singing four-part harmony, barbershop style
- B. to organize and maintain choruses and quartets
- C. to perform publicly and privately, to participate in contests, and to promote interest in and appreciation of barbershop harmony
- D. to promote friendship and good fellowship among all women
- E. to provide a harmonious climate wherein members and guests may enjoy the informal social atmosphere inherent in barbershop harmony
- F. to work constructively toward the expansion of Harmony, Inc.

**ARTICLE IV: Manner of Election**

- A. Nominating committee:
  - 1. A nominating committee of not fewer than three (3) and not more than five (5) shall be elected one month prior to the annual meeting.
  - 2. No more than one (1) of the members of the nominating committee shall be a member of the current executive committee.
  - 3. Nominating committee duties shall be outlined in the standing rules.
- B. Nominations and elections:
  - 1. Nominations shall include the nominees selected by the nominating committee and nominations from the floor.
  - 2. All nominees shall have indicated their willingness to serve.
  - 3. Election of the executive committee shall be at the annual business meeting and shall be by written ballot with plurality of vote election.
  - 4. The term of office for a member of the executive committee shall be two (2) years.
  - 5. Officers of the Chapter will be elected by the executive committee, from among its number, at its first regular meeting.


