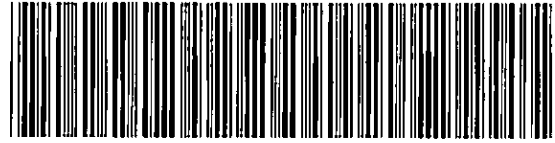

Changes made to the following Articles:

Article III: Line 3 and 4: Replace "Sunni" and "Sunni Muslim" with "Muslim".

Article IV, #1: Remove "Sunni".

Article IV, 4: Delete "No membership fee will be collected from anyone".

Add to Article IV, 4: "One must donate, for one year, at least \$100/month in the form of check or cash to the treasurer and continue to pay to maintain the membership status OR perform volunteer work for the Masjid for at least one year and continue to do so in order to maintain the membership status. Only the members will have the right to select the board members.

Article IV, ADD "Board of Trustees reserve the right to issue a no trespass on any person who creates Fitna or disturb the peace of the Masjid, inside or outside the premises. Any type of activity by any person that causes disturbances or hardship or distraction might lead to the suspension of the privilege of using the Masjid facilities inside and outside Masjid."

Article IV: Add " If there is an impasse and the community is split into two or more groups over some issue and cannot reach an agreement, the President may ask the leaders of the Fort Pierce Masjids to mediate and try to resolve the issue."

Article VI: On line 1, replace "four" with "five".

Article VI: On line 7, replace "six month" with "four years".

Article VI: Remove " The Mashwara will be conducted by the Responsible Brother (President) as practiced by the Tabligh Jamat. The Mashwara will be conducted with the natural members on a regular basis by the Shura. The decision of the Responsible Brother will be final".

Article X: Line 2, replace "Aziz Chagani " with "Shahwali Khan".
