ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

The Articles of Incorporation of the undersigned desiring to form a Non-Profit Corporation under the Non-Profit Corporation Laws of Florida do hereby certify:

Article 1

The name of the corporation shall be Spoon in the Hand, Inc.

Article 2

The principal street address is 13654 Bluewater Circle Orlando, FL 32828.

Article 3

The primary purpose for which the corporation is organized will be connecting existing humanitarian organizations in active conflict and crises zones around the world for the purpose of fundraising, networking, and aiding their work in needed areas of concern including education, economics, politics, religion, charities and the arts. The secondary purpose will be assisting the formation of humanitarian organizations where none are currently at work.

This corporation is organized and operated exclusively for charitable and educational purposes within the meaning of §501(c)(3) of the Internal Revenue Code.
