AMENDED ARTICLES OF INCORPORATION EMMANUEL TABERNACLE BAPTIST CHURCH APOSTOLIC FAITH INC. NORTH TAMPA

The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is:

The specific purpose for which this corporation is organized is:

The mission of this organization is to we believe in one great and enternal god. For the plan of salvation, to repent and be baptismze in 'the name of Jesus, serving the invisible and visible church, the lord supper. Said organization is organized exclusively, for the charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501©(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IV

The manner in which directors are elected or appointed is:

Directors are elected by the governing board of Emmanuel Tabernacle Baptist Church Apostolic Faith, Inc. North Tampa.

ARTICLE V

The manner in which earning and political campaign contributions are handle:

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other purposes or activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 © (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE VI

The manner in which the dissolution of the organization:

Upon the dissolution of the organization, assets shall be distribute for one or more exempt purpose within the meaning of section 501 © (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated for such purposes.
