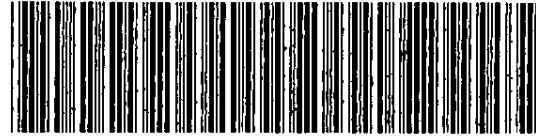



- Health and human services - counseling, case management healthcare referral services, and housing.
- Each boy and/or girl will have an individual treatment plan with clear goals and objectives.
