

ARTICLE I NAME

The name of the corporation shall be:

Hlami Association for Turtle Conservation and Hope Incorporated

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

The corporation is organized and shall be operated exclusively for charitable, scientific and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. Subject to the foregoing, the specific purposes and objectives of the corporation shall be to promote conservation and research of sea turtles and their habitats in Ghana, West Africa, while building community understanding and support for sea turtle conservation through education outreach initiatives. Upon dissolution, the assets remaining after payment of all debts and liabilities shall be distributed to an organization recognized as exempt under section 501(c)(3) of the Internal Revenue Code of 1986 to be used exclusively for charitable and educational purposes.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:
