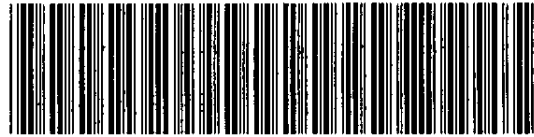

We, the undersigned incorporator, hereby make, subscribe, acknowledge and file with the Secretary of Florida, these Articles of Incorporation for the purpose of forming a Non-Profit Corporation in accordance with the laws of the State of Florida.

Articles III

The general nature of the business to be transacted by this Non-Profit Corporation, or the objects and purpose of the corporation shall be:

The purpose of the Teen Girls In Action shall be to enhance the lives and character of each young girl, by developing better citizens within the community; that will become well-round young ladies. Providing positive experiences that will nurture the mind, body and soul of young girls, in an at-risk situation, by enlightening their paths and creating balance in their young lives. Providing an opportunity that will embrace and cultivate a sisterhood, which uplift and encourage our young girls to recognize the importance of higher-education and self-esteem to be in a society of strong women to become one day leaders of tomorrow.

Section (2) The organization is organized exclusively for charitable, religious, educational, and scientific purpose under Section 501© (3) of the Internal Revenue Code, pr corresponding section of any future Federal Tax Code.

Section (3) Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501© 3of the Internal Revenue Code, or corresponding section of any future Federal Tax Code, or shall be distributed to the Federal Government, or to a state or local government, for a public purpose.


